## Introduction

To be known as the School of Biological Sciences Postgraduate All Round Achievement Award. This prize was set up by the School of Molecular and Biomedical Science in 2005. The prize is to be awarded to the postgraduate candidate who has completed and submitted the thesis for the PhD or MPhil program within 4 years and 2 years respectively and fulfilling additional criteria as listed below. The prize is to be awarded once per annum to the value of \$500.

Awarded for	To recognise and reward outstanding all-round achievement during postgraduate study, taking into consideration academic achievement, and service to the School or University, scientific societies and community.
Selection criteria	The award winner shall be determined by the School postgraduate convenor, in consultation
	with the postgraduate co-ordinator in each department in the School.
	• Service to the University, Scientific and general community (50% of total). Factors
	include:
	1. Service as postgraduate student representative
	2. School or University committee membership
	3. Contribution to School teaching programs
	4. Service to Scientific societies
	5. Conference Organisation
	6. Community involvement – School visits
	Research Publications (40% of total)
	1. Contribution to the field of research by journal articles arising from thesis
	2. Examiners reports for thesis
	3. Thesis awards

	1. Prizes for presentation at meetings
	2. Awards from scientific societies
	3. Competitive travel grants
Value of prize	\$500 or such other amount as the School of Biological Sciences shall from time to time determine.

	If the course given above is, for whatever reason, not run in a particular year the prize is not to
	be awarded. If in any year, the School of Biological Sciences considers that there is no
	candidate of sufficient merit, no award will be made. The award title and these rules may be
	varied from time to time by the Faculty in consultation with the School of Biological Sciences.
